## Over 1.5 million displaced people in Ukraine – Ministry of Social Policy

As of 28 September, a total of 1,505,570 displaced people from the Donbas and Crimea were registered with the Ministry of Social Policy of Ukraine. Over 505,000 IDP families have received social payments from the state, the Ministry reports.

## **UN Agencies, major NGOs ordered out of Luhansk**

The United Nations humanitarian chief Stephen O'Brien said he is alarmed that UN agencies have been ordered out of eastern Ukraine's separatist-controlled Luhansk region by the "de facto authorities" there. UN operations in Donetsk are also in peril, O'Brien said. "A decision by the de facto authorities in Donetsk on the U.N.'s future operations remains on hold, and all U.N. agency operations have been suspended."

O'Brien said the restrictions on humanitarian shipments have kept about 16,000 tons of supplies, including food and shelter from being delivered. "Hospitals cannot perform surgery because they lack anesthesia," he said. "Some 150,000 people are not receiving monthly food distributions." He said the suspension of shipments is putting lives at risk and is "having a serious impact on some 3 million people as winter approaches."

## **Kyiv bans Russian airlines' flights**

Ukraine has said it will ban Russian airlines from flying into the country as part of sanctions over Moscow's support for rebels in the east. Kyiv said the measures would take effect on 25 October and would include major Russian airlines Aeroflot and Transaero. Russian transit flights will also be banned if the planes carry military personnel or dual-use goods.

## Poland to bring in ethnic Poles from Kazakhstan, Ukraine and elsewhere

Poland has earmarked funds to bring in tens of thousands of ethnic Poles now living in Kazakhstan, Ukraine and other former Soviet republics, its finance minister said.

The issue was raised recently amid a heated debate over the European Union's plan to share 120,000 refugees from the Middle East, Africa and Asia among its 28 members. Poland has said it will host 7,000 of them. Critics of the refugee program, however, say Poland's first obligation is toward the ethnic Poles who Soviet dictator Josef Stalin expelled by hundreds of thousands from their homes, and to their descendants.

# Border unit in Western Ukraine reconstructed with funding from EU

Under the project, 30 administrative, residential, household and public buildings were reconstructed, with the installation of a water supply network, replacement of heating supply networks and construction of a new boiler-house and renovation of official apartments for the military personnel stationed at the unit.
